



**Boarding Agreement**

This agreement is effective for all pet boarding and services rendered at any times in the future. I understand that rates, hours and services may change without prior notice to arrivals. This agreement constitutes permission to board said animal and perform duties as stated in the relevant Pet Information Sheets. Any changes to this agreement must be done so in writing or they will be null and void. CCC has the right to make any changes to this agreement at will and without notice.

**Policies & Procedures**

The client hereto agrees as follows:

- 1) CCC (Ivy's Canine Country Club LLC) and its employees agree to provide services stated in this agreement in a reliable and trustworthy manner. In consideration of these series and as an express condition thereof, the client expressly waives all claims against CCC or its employees, unless arising from negligence on the part of CCC.
- 2) The client understands that all pets must have a veterinarian and **must be current with all vaccinations**. Vaccinations must be given far enough in advance to be effective. **All Vaccinations need to be administered by Veterinarian. Bordetella** "Kennel Cough", **DHP-PV** "Distemper, Parvo, Hepatitis and Parainfluenza" and **Rabies**. Please bring the vaccination record with you before or during admission of pet(s) **or we will not be able to admit your pet**.
- 3) The client understands that all pets must be treated with a flea, tick and heartworm preventative. If fleas are found on pet, a flea bath will be given at owner's expense.
- 4) CCC reserves the right to decline boarding to a pet that is not spayed, neutered or determined unsafe to staff or other dogs.
- 5) The client understands that we will not administer sedatives to your pet -- regardless if they are veterinarian prescribed. If your pet needs this type of medication you need to make arrangements for your pet to be hospitalized with your veterinarian.
- 6) CCC does not diagnose or make therapy decisions nor does it offer veterinary services. Any veterinary/medical concerns will be referred to a veterinarian.
- 7) CCC will not board/sit for acutely ill animals or those with uncontrolled medical conditions. We suggest the pet be boarded with a vet. Certain medical conditions may also be referred to a veterinarian for boarding. Pets infected with Feline Aids, FIP, or ringworm will not be admitted since they are highly contagious diseases.
- 8) The client understands that they must express any known behavioral and/or aggression problems. Client is solely responsible for any harm caused by their pet to any employees, other pets/owners, or property.
- 9) CCC does provide food, bowls, and bedding; however, you may provide your own food and CLEAN bedding, CCC is not responsible for those items. Please label all items including medications with pet's name.
- 10) CCC does not always accept aggressive animals; however, when accepted, these animals will not have any interaction with other.
- 11) All dogs must arrive on a leash. All cats must arrive and depart in a carrier.
- 12) CCC reserves the right to take pet(s) to veterinarian if necessary. Client is responsible for all charges.
- 13) CCC reserves the right to deny service or terminate service because of safety concerns, financial concerns, or inappropriate or uncomfortable situations.
- 14) The client agrees if pet is not picked up, or we are not notified, within 10 days after scheduled pick up date, CCC will consider the pet abandoned and pet will be dropped off at nearest shelter.
- 15) Payment may be expected before services are rendered for unforeseen costs (such as food, supplies, or vet fees). A Deposit is required on all stays over three weeks. Payment is expected at check-out time. A late charge of \$25 will be applied otherwise. CCC will begin legal action for non-payment after 21 days.
- 16) There will be a \$12.00 fee for post A.M. pick-up and additional \$20.00 fee for any after closing hours' pick-ups if available.
